Jean-Paul Coutard has made a name and a reputation for himself after he unveiled the first modern bus to be made in Haiti during a presentation in July 2013.

The CEO of Coutard Motors manufactured other 56-seat buses, most of which are operated by the company Patrick Coach Line which connects St-Louis-du-Nord to Port-au-Prince via Port-de -Paix. The latest creation from its assembly line, a 30-seater, air-conditioned minibus, designed to travel on our bumpy roads, put the former electromechanical student of the Diesel Institute of Haiti and a body shop in Canada under the spotlight.

In his morning interview with Magik 9 (100.9 FM), he did more than just market his projects and ambitions.

Coutard, without ever raising his voice, dazed the chefs who used his creation to make "a media circus". He contradicted reports that publicity had helped him increase production.

Coutard praised people he knew but no no longer keep in touch with, including Jovenel Moïse when the two men presented their projects in 2013. The president was then CEO of Agritrans and Coutard of CoutardMotors.

"The current president and I represented, in 2013, a great hope for modernization," Coutard said. "Even if we know that national production is not very interesting to those who run the country, I still salute the presidency this morning," he said, stressing that Chinese officials had praised his work.

And now? "I can't hear anyone," replied Coutard. Continue reading.

"Global cooperation is the only way out of this #coronavirus pandemic, #TeamEurope stands by its partners," Urpilainen said in a tweet, thanking President Kagame for the "constructive discussion." The EU cooperates in areas of energy and infrastructure, rural development and food security, as

well as governance, civil society and human rights, among others.

Congo suspends board and management of state diamond miner MIBA

The Democratic Republic of Congo has suspended the board of directors and management of state-controlled diamond mining company MIBA, after an audit revealed significant irregularities, the government said in a statement.

The audit identified a host of problems including compliance, governance, production and financial management, the statement by Congo president's office said following a council of ministers meeting on Friday.

It added that Congo's mines ministry will propose measures to revamp the company.

Founded in 1961, MIBA was formerly a jewel in minerals-rich Congo's minerals industry, with gold, nickel and cooper in its portfolio. However, years of mismanagement, illegal mining, smuggling, and political instability have hobbled the company.

Dozens of villagers have been killed by suspected Ugandan rebels in the northeastern Democratic Republic of Congo, local media reported.

The attacks, thought to be carried out by the Allied Democratic Forces (ADF), targeted multiple villages in Irumu territory, Ituri province between Monday and Tuesday, according to local news website Actualite.cd in a Tuesday report.

"We are mourning, the security situation has become very complicated here with the ADF rebels. Yesterday evening, they raided Samboko village killing 14 people and [...] they also attacked Tikamaibo village precisely on the Mutuyei hills,

"At the moment, we have recorded 40 dead. Several bodies are abandoned in the bush because the hill is currently inaccessible according to the victims' families," Dieudonne Sonyau, a civil society leader, was quoted by Actualite.cd as saying.

Some 17 civilian bodies were found in Irumu territory, the Kivu Security Tracker (KST) said on Twitter late Tuesday.

Since 7 May, the KST has recorded the deaths of 50 civilians attributed to the ADF in Beni territory alone. In April, the KST recorded the deaths of 30 civilians due to the same insurgent group, KST added.

KST is a joint project of the Congo Research Group and UN Human Rights Watch. It maps violence, analyzes trends and documents human rights violations in Eastern Congo.

Increased attacks

Attacks on civilians have mounted in recent months in the eastern DRC, triggering protests in Beni last December, where locals blamed the UN peacekeeping force, MONUSCO, for failing to protect them.

The army launched an offensive in January against militias operating in the gold-rich province of Ituri as part of a wider offensive launched last October.

The ADF rebel group -- which originated in neighboring Uganda in the 1990s -- has been attacking and killing civilians in the eastern Democratic Republic of Congo for over two decades.

ADF rebels have set aside their political demands and are mostly involved in the trafficking of minerals in the eastern DRC, which has abundant gold deposits.

Les médias kinois de ce jeudi reviennent sur la disparition du juge président du procès de 100 jours. Raphaël Yanyi Ovungu, juge-président du Tribunal de Grande instance de Gombe et juge chargé du procès de Vital Kamerhe, directeur de cabinet du chef de l'Etat, et de Samih Jammal, directeur général de la société Samibo, poursuivis pour détournement présumé est décédé le 27 mai, rapporte Le Phare.

L'homme, selon des sources familiales, a été pris de malaise en début de soirée du mardi 26 mai 2020, chez lui et a rendu l'âme au Centre Hospitalier Nganda.

Mais avant son transfert à l'hôpital, fait remarquer le quotidien, ses proches ont constaté que sa peau était devenue toute noire. Cette mutation subite les pousse à croire à un empoisonnement, conclut le journal.

Cas-info.ca indique que le juge Yangi était marié et père de trois enfants.

« Il était sorti, il est rentré et tout d'un coup, il a ressenti des malaises. On l'a amené à l'hôpital Nganda vers 23 heures et c'est là que nous avons appris sa mort. C'est un juge de la république. Il est mort comme un soldat au front. Nous ne pouvons pas supputer sur sa mort pour l'instant», a déclaré un membre de sa famille dont les propos sont repris par le site web.

Au sein de sa famille, décrit Actualite.cd, c'est la désolation. Certains responsables de la famille exigent qu'une autopsie soit effectuée sur le corps, ajoute le site web. Et la justice n'a pas attendu pour exiger cette autopsie.

A en croire Mediacongo.net, après l'annonce du décès du juge Raphaël Yanyi, une réquisition de l'officier du ministère public a saisi le médecin directeur général de l'Hôpital militaire du Camp Kokolo à Kinshasa pour examiner la dépouille du défunt juge et déterminer la cause du décès.

Il faudrait également noter que le parquet de grande instance de Kinshasa/Gombe a ouvert une information judiciaire autour de ce décès mystérieux, ajoute le portail.

Pour sa part, 7sur7.cd, note que le Parquet de Grande instance de Kinshasa Gombe a demandé en "urgence" au médecin légiste de l'hôpital général de référence de Kinshasa de procéder à l'autopsie du corps du juge Raphaël Yanyi.

« Examiner le corps du feu Raphaël Yanyi Ovungu conservé actuellement à la morgue de l'hôpital Général militaire du camp Kokolo et nous déterminer les causes de son décès", a écrit l'officier du ministère public Émile Ndjale.

Il a également exigé au directeur de l'hôpital général militaire du camp Kokolo de "veiller", à ce que le "corps ne soit pas manipulé par des mains inexpertes jusqu'à l'exécution du devoir de requis", précise le site web.

Rwanda authorities hand over Ugandan suspect

Uganda's new COVID-19 cases hit record high, 84 reported

Among the new cases, 52 are truck drivers while 32 are contacts of previously confirmed cases.

Uganda recorded the highest figure of new COVID-19 cases as 84 new patients were registered on Saturday.

The new cases, according to the Ministry of Health, bring the total confirmed cases to 413.

Among the new cases, 52 are truck drivers while 32 are contacts of previously confirmed cases.

Of the truck drivers, 50 arrived from South Sudan via Elegu, while two arrived from Kenya via Busia.

All the cases from the community were under quarantine at the time of testing.

"Additionally, 51 positive foreign truck drivers were handed over to their countries of origin," the ministry said.

Uganda has so far registered 72 total recoveries with no single death related to the virus.

The ministry said on Saturday they tested 1,477 samples from points of entry while 358 were got from alerts and contacts.

Uganda has since started easing the COVID-19 lockdown, with shops that are not located in arcades and malls being allowed to operate.

Private cars – apart from those in districts at border area – have also been allowed back on the roads. The cars are, however, are allowed to carry only three passengers.

The country is also set to allow public vehicles – under strict guidelines – back on roads.

The Government will distribute free masks to all citizens in the country. Thereafter, no one will be allowed to appear in public places without wearing a masks.

Uhuru to chair virtual summit on impact of pandemic

President Uhuru Kenyatta (pictured) will attend a continental summit to assess the Covid-19 impact on African, Caribbean and Pacific states.

The President-in-Office of the Organisation of African, Caribbean and Pacific States (OACPS) and President Uhuru Kenyatta are on Wednesday expected to convene the first ever Extraordinary Inter-Sessional Summit of the Heads of State and Government.

The virtual Summit, which is hosted by the OACPS, aims to assess the current global Covid-19 situation, and in particular, the effects and consequences to the members of the OACPS.

In addition, members will identify opportunities for global solidarity and action. Kenyatta on Friday announced plans to host an extraordinary summit to deliberate on the effects of Covid-19 on the people and the economies of member countries.

Themed "Transcending the Covid-19 Pandemic: Building Resilience through Global Solidarity", the Extraordinary Inter-Sessional Summit will consist of a dialogue by the Heads of State and Government of the OACPS, which will be followed by a high-level exchange with global strategic and development partners, who will be key to achieving the objectives identified by the Heads at the summit.

Members of the OACPS share several unique challenges which have been intensified by the Covid-19 crisis. The pandemic threatens recent advances in health and progress towards global sustainable development goals. Job losses and an increased debt burden are some of the immediate challenges. Members of the OACPS are among some of the poorest countries in the world and are, as a result, more at risk to the devastating socio-economic consequences of the pandemic.

The vulnerabilities are equally high for the Caribbean and Pacific, which mostly depend on single sectors, especially tourism.

The Covid-19 crisis also has the potential to spark a food security crisis especially in Africa, with agricultural production potentially contracting by between 2.6 per cent in an optimistic scenario and up to seven per cent if there are trade blockages.

There is therefore an urgent need to work with global health leaders, partners and governments to ensure that the global response to Covid-19 includes lessons learned from other epidemics and communicable diseases, particularly as it concerns the protection of vulnerable populations.

Held simultaneously across the four time zones in which the OACPS operate, the summit is expected to focus on three pillars, which include building resilience, keeping economies functioning and rebooting for a strong recovery and boosting global solidarity and deepening partnerships.

At the conclusion of the summit, the OACPS leaders are expected to endorse a communique based on the mentioned three pillars.

Kenyatta became the OACPS's head in December 2019. In a recent communique, he said the summit will make specific pronouncements on intended approaches that will ensure that the effects of the pandemic have minimal economic disruptions.

South Sudan Vice President Tests Positive for Coronavirus

James Wani Igga said on the state-owned South Sudan Broadcasting Corp. that his test results had come back positive.

"My samples [were] taken for testing a few days ago and today it has been found positive for corona," he said. "And so, I encourage all South Sudanese to really go for testing. This is very important so that we stop the spread of this pandemic to more people."

Igga was the fifth senior South Sudanese official to test positive for the coronavirus.

The newly appointed chairman of South Sudan's reconstituted National Committee on COVID-19, Fifth Vice President Hussein Abdelbagi, tested positive last week.

First Vice President Riek Machar Teny and his wife, Minister of Defense Angelina Teny, tested positive two weeks ago.

The South Sudan government's spokesperson, Michael Makuei, said on May 20 that he and all those on the nation's 15-member coronavirus task force had tested positive for the virus.

'Wear it properly'

Dr. Anthony Garang, acting chairman of the South Sudan Doctors' Union, said many South Sudanese, including the task force members, were contracting the virus because they refused to follow preventive measures, such as wearing face masks.

"Using the masks has its own ways. It does not mean that when you are wearing a mask, that is it. You need to wear it properly," Garang said. "You need to put it on properly. And once you put it on, you need to make sure you don't remove it, you don't touch it with your hands and touch other parts of your body with it. That is one particular thing that was missed. People could wear a mask, and when they want to talk, they pull it down and they talk. Then, they put it back and they don't immediately wash," Garang said.

South Sudan Health Minister Elizabeth Acuei Yol replaced Dr. Angok Gordon Kuol, the country's coronavirus incident manager, on Wednesday and appointed Dr. Richard Lino Lako as the new incident manager. There were no reasons given for this shuffle.

In mid-May, South Sudan health officials announced the country's first death from COVID-19. A top health official described the deceased as a 51-year-old "high-profile South Sudanese."

The person had arrived at a military hospital in Juba in critical condition, according to Health Ministry Undersecretary Dr. Makur Matur Koriom, who is also a member of South Sudan's High-Level Taskforce for COVID-19.

South Sudan has registered 994 COVID-19 cases, six recoveries and 10 deaths.

Various South Sudanese stakeholders are expressing fears that the country is likely to experience a catastrophic level of coronavirus infections if authorities do not strictly enforce measures.

As of Wednesday, the country confirmed new 188 Covid-19 cases, which brought the total number of confirmed cases nationwide to 994, with six recoveries and 10 deaths.

South Sudan was the last country to confirm its first Covid-19 case since the outbreak in the region, but now it second to Kenya in the region with the numbers of cases, having skipped Uganda, Rwanda, Tanzania and Burundi.

Speaking to The EastAfrican on Wednesday in Juba, various stakeholders said that if authorities don't act fast to fix the current crisis, the country will have the highest Covid-19 numbers in the region.

Matiop Kuol Akech, a resident of Lologo suburb in Juba, says the virus will mostly affect the livelihoods of the vulnerable population if not properly handled. He was worried that increased cases are interfering with people's planned activities affecting future prospects of business.

"In addition, people in the grassroots are not well informed about the dangers of the pandemic. The more the locals mingle among themselves, the more the cases will increase, something that is happening currently and worrying," Mr Matiop stressed.

He wants the government to prioritise grassroots awareness campaigns

Ramaphosa calls for end of oppression of Palestinians, freedom for their homeland

The chairman of the African Union, who is also the president of South Africa on Monday, called for the unconditional lifting of sanctions on Sudan and Zimbabwe.

"As we deal with the impact of this [novel coronavirus] pandemic, we repeat our call for the unconditional lifting of sanctions that have been imposed on Zimbabwe and Sudan," Cyril Ramaphosa said in a televised address marking Africa Day.

The US has sanctions imposed on Sudan, accusing it of sponsoring terrorism, while Zimbabwe was sanctioned for rights abuses and irregular elections during the leadership of late President Robert Mugabe.

As a result of the sanctions, the two African countries cannot access much-needed aid to fight COVID-19 and purchase medical supplies. About 96,000 people have been infected with COVID-19 in Africa and almost 3,000 have died.

Ramaphosa also called on developed countries, multilateral institutions and donors to provide vulnerable countries -- especially in Africa -- with the necessary support in the form of diagnostic and therapeutic medical supplies.

He also said they could assist with the necessary financial support to sustain the livelihoods of vulnerable people.

"We repeat our call for a comprehensive, robust economic stimulus package for Africa that includes debt relief and other support measures for the continent's immediate humanitarian needs and necessary economic recovery," he appealed.

Ramaphosa urged African leaders to ensure that the pandemic did not reverse developmental gains.

"We must not under any circumstances allow this global health emergency to derail our efforts to silence the guns on the continent," He said.

Ramaphosa said tragic conflicts must end as they destabilized a number of African countries and exacted a heavy toll on human life.

"We must continue to affirm the supremacy of dialogue over military intervention," he said.

Ramaphosa added that as Africans, they would continue to stand on the side of justice and called for an end of the oppression of the Palestinian people and occupation of their homeland.

Sudan: Talks continue with Ethiopia on border tension

Sudan's army said on Friday that diplomatic contacts with Ethiopia to contain border tensions were ongoing.

The Sudan's army spokesman, General Amer Mohamed al-Hassan, said in a statement that one Sudanese officer had been killed and seven other soldiers injured due to attacks launched by Ethiopian militias backed by the Ethiopian army.

"We decided to give chance for diplomacy in Khartoum and Addis Abbas to calm the situation on the border strip before it turns into an all-out war between the two countries," said al-Hassan.

He added that the recent attacks on Sudanese territory by the Ethiopian army and militias violated previous agreements between the two countries.

Al-Hassan called on Ethiopia to abide by its agreements with Sudan on their mutual boundaries, along with deployments of official forces on either side of the border.

On Thursday, a Sudanese army officer and a child were killed and seven other soldiers were injured as a result of attacks by Ethiopian militias in the border areas in the past two days.

Ethiopia has yet to comment on the accusations.

Sudan and Ethiopia have been engaged in continuous talks over the demarcation of the borders between the two countries.

Sudan summons Ethiopian Diplomat over deadly border clashes

The top Ethiopian diplomat in Sudan was summoned to the Foreign Ministry in Khartoum on Saturday after several Sudanese troops and civilians were killed in an attack by Ethiopian militants.

The state-run Sudanese news agency SUNA said Ethiopian villagers living in border areas frequently trespassed to Sudanese land to plant and harvest crops.

Ethiopia's COVID-19 cases surpass 1,000 as 95 new cases confirmed

ADDIS ABABA, May 30 (Xinhua) -- Ethiopia's confirmed COVID-19 cases reached 1,063 after 95 new cases were confirmed on Saturday, the Ethiopian Ministry of Health said on Saturday.

The Ethiopian Ministry of Health, in a situation update statement issued on Saturday, revealed that from the total of 5,034 medical tests that were conducted in the last 24 hours, 95 of them tested positive for COVID-19, eventually bringing the total number of cases to 1,063 as of Saturday afternoon.

According to figures from the ministry, 94 of the latest confirmed cases are Ethiopian nationals while the remaining one is said to be an Indian national, comprised of 71 males and 24 females and with their age ranging from 15 to 80 years old.

The ministry said that from the total of 95 new COVID-19 cases, some 30 are said to have travel history from abroad, 4 having contact with known confirmed cases, while the remaining 61 are said to have no travel history from abroad as well as without prior contact with known confirmed cases.

The ministry said that some 208 patients who tested positive for COVID-19 have so far recovered from the virus, of whom some 11 of the patients recovered during the past 24-hours period.

The Ethiopian Ministry of Health has previously reported eight deaths due to illnesses related to the COVID-19, in which the latest COVID-19 death is a 62-year-old man who succumbed to the disease on Friday, according to the ministry.

Ethiopia, Africa's second most populous nation with about 107 million people, confirmed its first case of COVID-19 on March 13.

The Ethiopian government has instituted a wide range of measures to contain the spread of COVID-19.

In April, the Ethiopian House of People's Representatives, the lower house of the Ethiopian parliament, announced a five-month state of emergency to curb the spread of COVID-19 in the country. Enditem

Ethiopia, Sudan discuss 'misunderstood' Nile dam issues

Ethiopian prime minister says two sides will continue talks through water ministers

ADDIS ABABA, Ethiopia

Ethiopia and Sudan on Thursday agreed to continue efforts for "win-win solutions" to the dispute over the Nile dam project.

Ethiopian Prime Minister Abiy Ahmed and his Sudanese counterpart Abdella Hamdok held a virtual meeting to discuss issues regarding the \$5 billion Grand Ethiopian Renaissance Dam (GERD).

In a series of tweets, Ahmed said the two sides "addressed misunderstood issues" and explored ways to reach "an amicable solution."

"We have agreed to continue with technical level engagements through our Water Ministers tasked to discuss outstanding issues and arrive at win-win solutions," he said.

"I also reiterated the economic advantages of the GERD for all that we can seize through the spirit of collaboration."

Hamdok, who has been trying to convince Ethiopia to resume trilateral talks with Cairo, also held discussions with Egyptian Prime Minister Mustafa Madbouli on Tuesday.

US-sponsored talks between the three countries broke down in February after Ethiopia accused Washington of siding with Egypt.

Cairo opposes the hydropower project that Ethiopia started building in 2011 on the Blue Nile, a tributary of the Nile River, near the border with Sudan.

Tensions between Egypt and Ethiopia have escalated as the latter prepares to start filling the dam this July, as agreed in a prior accord.

The Declaration of Principles (DoP) signed by the three countries in 2015 provided that negotiations would continue along with the dam's construction.

While a resumption of tripartite talks seems on the cards, it remains unclear whether the upcoming negotiations would be mediated.

Ethiopia has earlier said it would prefer mediation by an African partner, while Egypt maintains it is "always ready" for negotiations.

The GERD's construction is expected to finish by 2023 and the hydroelectric dam will produce 6,475 megawatts for Ethiopia's domestic and industrial use, as well as for export to neighboring countries.

Ethiopia plans to fill it up over four to seven years starting this July, but Egypt wants the pace to be even slower.

Cairo says it has a "historical right" to the Nile waters, a claim that Ethiopia has categorically rejected.

EU welcomes resumption of Ethiopian Renaissance Dam negotiations

https://egyptindependent.com/eu-welcomes-resumption-of-ethiopian-renaissance-dam-negotiations/ EU High Representative for Foreign Affairs and Security Policy Josep Borrell on Thursday welcomed the resumption of negotiations between Egypt, Sudan and Ethiopia regarding the Grand Ethiopian Renaissance Dam (GERD), and stressed the importance of reducing tensions between the three parties.

During his conversation with African Union Commissioner for Peace and Security Ismail Sharqi, Borrell emphasized the importance of seeking a solution that satisfies all three parties, and said that Brussels is ready to provide support.

Sudanese Minister of Irrigation and Water Resources Yasser Abbas held two separate meetings on Monday with his counterparts, Egyptian Minister Mohamed Abdel-Ati and Ethiopian Minister Seleshi Bekele, to discuss arrangements for the resumption of negotiations on the dam.

The Sudanese Ministry of Irrigation said in a statement that the two meetings were held via video conference and in the presence of members of the technical negotiation delegation from each of the three countries involved.

The ministry also said that the meetings occurred as a result of recent meetings held between Sudanese Prime Minister Abdalla Hamdok and his Egyptian and Ethiopian counterparts.

Following the meetings, all three countries' water ministers were instructed to make arrangements for the resumption of negotiations on the GERD as soon as possible.

The Sudanese News Agency reported Hamdok as saying that Sudan is ready for continuous communication with the two countries to reach an agreement that guarantees full consensus between the three parties and takes into account their respective interests.

Commenting on the latest developments, Professor of Water Resources at the Africa Research Institute at Cairo University Abbas Sharaqi said that Ethiopia's attempts to return to the negotiating table to resolve differences over the GERD are unpredictable.

Sharaqi stressed the need to complete the negotiations begun in Washington and to refuse to allow Ethiopia to close this path, something it had previously stipulated as a condition for its return to negotiations.

He added that Ethiopia aims to waste time, bifurcate the GERD issue and incite new problems between Egypt and the upstream countries that Ethiopia is encouraging to demand a share of the Nile's water.

Negotiations were suspended in February after Ethiopia refused to sign a draft agreement prepared by the United States and the World Bank.

Sudan on May 12 rejected Ethiopia's proposal to sign a partial agreement to start filling the reservoir of the dam in July.

Ethiopia has announced its plan to store 4.9 billion cubic meters of Nile waters in the reservoir of the dam in July, while Cairo insists on adhering to the Washington talks on filling and operating rules for GERD, as well as to the declaration of principles signed between the three countries in 2015.

Egypt's Ministries of Foreign Affairs and Water Resources has rejected Ethiopia's plan to fill the reservoir of the GERD before construction work is finished and regardless of whether an agreement has been reached with downstream countries.

Egypt relies considerably on fresh water from the Nile and has voiced concerns that the GERD would negatively impact the country's water supply, especially in light of overpopulation fears, and has thus insisted throughout negotiations that measures be put in place to protect downstream countries in case of drought during the filling process at the dam.

Ethiopia pours water on Egypt's Nile rights claim ahead of crunch dam talks

CAIRO: Ethiopia has opened the floodgates to further controversy over a giant dam scheme by rejecting Egypt's historic claims to the waters of the Nile.

Ahead of the anticipated resumption of stalled talks over the Grand Ethiopian Renaissance Dam (GERD) project, two Ethiopian ministers poured water over the Egyptian stance on river rights.

In a speech to political party representatives and religious leaders regarding the latest developments in GERD negotiations, Ethiopian Minister of Water, Irrigation and Energy Seleshi Bekele said the talks, also involving Sudan, were being "clouded by Egypt's tendency to recall and confirm the so-called (historic rights) in water, which can never be accepted by Ethiopia or Nile-sharing countries." Ethiopian Minister of Foreign Affairs Gedu Andargachew added that his country's position was firm with regard to utilizing its water resources in a fair way "in accordance with the agreed cooperation principles and not causing any major damage."

Meanwhile, Ethiopian religious leaders have called on the government to press ahead with the construction of the dam while negotiating with Nile-sharing countries.

Ethiopia's official news agency ENA, reported that a statement issued during a press conference by the Ethiopian inter-religious council of seven institutions, "underlined Ethiopia's natural right in developing the Nile." The council also called for the resumption of tripartite discussions.

Ethiopian Orthodox Tewahedo Church Patriarch Abune Mathias said the government needed to continue with construction of the dam on the basis of mutual understanding with upstream countries and without any foreign intervention.

Mathias pointed out that the Ethiopian people had played a big part in funding the project in the hope of improving their living conditions and seeing the development for their country, adding that work should carry on "for the sake of the people" without causing any damage to Nile-sharing countries.

Cardinal Berhaneyesus Demerew Souraphiel, head of the Ethiopian Catholic Church, said that Ethiopia had "the right to develop its rivers in order to provide electricity for millions of its citizens, just like Egypt did. Egyptians are provided with electricity better than the Ethiopians. In our situation, students and families do not have electricity.

"Upstream countries must know that the Ethiopian people do not have the intention to harm Egypt or Sudan," he added.

Ethiopian Islamic Affairs Supreme Council Secretary-General Sheikh Qassem Mohammed Tag El-Din also agreed that Ethiopia should carry on with building the dam "in the best interest of its people who are living in darkness and who do not have electricity.

"Concerning the dam, we need to stand together in harmony and even make sacrifices if this is what it takes to complete the project," he added.

The tripartite negotiations, which have been stalled for several months, are close to resuming.

The Sudanese Ministry of Irrigation announced that two separate meetings were recently held between Sudanese Minister of Irrigation and Water Resources Yasser Abbas and his counterparts from Egypt and Ethiopia, Mohammed Abdel-Ati and Bekele, respectively.

The ministry added that two members of the delegation from each country attended the meetings which had been set up to pave the way for fresh GERD negotiations.

In a statement, Sudan's irrigation ministry said that the ministerial meetings had followed recent talks held between Sudanese Prime Minister Abdullah Hamdok and his Egyptian and Ethiopian counterparts.

Abbas Sheraqy, professor of water resources at Cairo University's faculty of African studies, said Ethiopia's attempts to return to the negotiation table to settle the GERD issue had swung between resumption and manipulation.

He pointed out that Ethiopia was ready to resume GERD discussions despite having failed to attend the final day of the last round of negotiations in Washington in February last year, when it was due to sign an agreement, drafted by the US in collaboration with the World Bank, on the filling and operation of the dam.

Ethiopia's U-turn did "not befit a sovereign state that is a UN member under the pretext that it needed more consultations, as if nine years of negotiations were not enough," he added.

Sheraqy underlined the need to resume the talks in Washington and not to allow Ethiopia to cancel them which, he said, was its precondition to resuming them. He added that Ethiopia recently called for allowing downstream countries to attend the negotiations under the umbrella of the African Union.

Addis Ababa, he noted, was aiming to waste time and further complicate the GERD issue and was pushing Egypt into a new issue with downstream countries.

Egypt has stressed during its negotiations with Ethiopia the need to maintain its historic rights to the Nile waters. A 1929 treaty (and a subsequent one in 1959) gave Egypt and Sudan rights to nearly all of the Nile waters. The document also gives Egypt veto powers over any projects by upstream countries that would affect its share of the waters.

Ethiopia launched construction in 2011 on the Blue Nile in the northern Ethiopian highlands, from where 85 percent of the Nile's waters flow.

One of Egypt's main worries is that if the water flow diminishes, it could affect Lake Nasser, the reservoir further downriver, behind Egypt's Aswan Dam.

Ethiopia said that 73 percent of the GERD project had been completed. Its government is to start deliberations within a month on a date to start filling the dam.

Ethiopia: 30,000 violence-exiled people return

Upon return, internally displaced people also demand government give assurances of their safety Addis Getachew Tadesse | 26.05.2020

ADDIS ABABA, Ethiopia More than 30,000 internally displaced people (IDPs) in western Ethiopia have been brought back to their homes after two years of living in camps in the adjoining Amhara region, said local media.

Over the last two years violence displaced more than 49,000 people from their homes in the Metekel Zone in the Benishangul Gumuz state, the Amhara Mass Media Agency (AMMA) reported on Tuesday.

The returnees are demanding that the government give them assurances on their future safety, the agency said.

Following the eruption of violence in villages in adjoining regional states, a command post had been established to implement a state of emergency there, according to the local media.

The IDPs' return was made possible by the collaborative efforts of the two regional state governments and the army now that the security situation has greatly improved, it said.

"The returnees will receive food rations that will be enough for two months," AMMA quoted Etagegnehu Ademe, deputy commissioner of the Amhara Disaster Prevention and Food Security Commission.

Earlier, more than 9,000 displaced people were repatriated after the Command Post overseeing security in conflict hotspots in the adjoining regional states was able to confiscate 34 firearms and 681 bows.

According to the report, 41 of 71 people suspected of instigating the violence were convicted and are serving prison terms.

More than 12,000 undocumented Ethiopian migrants had been flown back to their country since the coronavirus outbreak, the International Migration Organization said.

Speaking to Anadolu Agency, Alemayehu Seifeselassie, IOM's communication officer in Ethiopia, said: "The returnees are mainly from Sudan, The Kingdom of Saudi Arabia, Djibouti and Kenya."

"Since April 2020, the total number of Ethiopians who have returned is over 12,032," he said.

"We expect the return to continue over the coming weeks," he added.

The returnees, according to reports, include 11 Ethiopians who survived the gruesome incident occurred in March in Mozambique where 64 Ethiopians were found dead in a cargo container on a truck bound for South Africa.

More than one million Ethiopian migrants work in the Middle East, many of whom are undocumented and now stranded after the outbreak of the pandemic.

Last month, Saudi Arabia flew hundreds of migrants back to Ethiopia. A first Saudi flight carrying hundreds of migrants was denied landing at the Addis Ababa Bole International Airport, with Ethiopia claiming it had not been informed beforehand about the operation.

Somalia looks to first full elections in 51 years, despite COVID-19 crisis

James Swan, Head of the United Nations Assistance Mission for Somalia (UNSOM), told the Security Council that 2.6 million internally displaced persons are particularly at risk from the novel coronavirus.

Somalia coronavirus cases

In its latest situation report, the World Health Organization (WHO) on Wednesday put the number of confirmed cases in Somalia at 1,502, with 59 deaths.

Even before the outbreak, more than 5 million Somalis required humanitarian assistance, Mr. Swan said, as the country continued to deal with the al-Shabaab terrorist insurgency and a major locust invasion that is putting food production in peril.

COVID-19 is also having a severe economic impact, with remittances from the Somali diaspora dwindling and the federal Government projecting an 11 per cent drop in nominal GDP this year, he said.

Nevertheless, the Federal Government and Federal Member States have responded quickly to the crisis "within their means," he said, with Prime Minister Hassan Khaire leading a National COVID Task Force and the six regional states participating in national-level coordination efforts.

"The UN family is working to reinforce the Government's response", he said, noting that the WHO is helping to expand Somali hospital and testing capacity, with the United Nations Development Programme (UNDP) also providing electricity generators.

Somalia's response is greatly aided by having achieved the so-called decision point under the Heavily Indebted Poor Countries (HIPC) Debt Initiative, on 25 March, enabling it to tap into additional budget support and grant financing from global institutions, he said.

Looking beyond the immediate health crisis, Mr. Swan – speaking from Mogadishu via video-teleconference – said the coming weeks will be decisive in determining how Somalia will proceed with its first direct elections since March 1969.

In the coming weeks, a parliamentary Ad Hoc Committee will make recommendations to resolve outstanding electoral issues, while the head of the National Independent Electoral Commission will report on plans to conduct the vote within a constitutional timeframe.

The pathway to a vote for all

"These Somali institutions will determine the pathway to elections," said Mr. Swan, urging Somalia's partners to be ready to mobilize the technical support and financial resources needed to make the landmark polls a success.

"We regret that al-Shabaab has not embrace the Secretary-General's appeal for a global ceasefire (in response to the pandemic) and that their terrorist operations continue unabated," he said.

He added that regrettably, due to COVID-19, the pace of future military operations could be impacted by a slowdown in international partner training needed for the fight against the terrorist group.

Mr. Swan's briefing to the Council followed the release of the Secretary-General's latest report on the situation in Somalia. The Council is due to decide on renewing AMISOM's mandate by 31 May and UNSOM's mandate by 30 June.

Madagascar President Andry Rajoelina has slammed the World Health Organization for not endorsing its COVID-19 herbal cure.

Last month, the Malagasy president officially launched Covid-Organics (CVO), an organic herbal concoction, claiming that it can prevent and cure patients suffering from the novel coronavirus.

"If it were a European country which had discovered this remedy, would there be so many doubts," he said in an exclusive interview with France 24, Paris-based international television news network and Radio France International.

"The problem is that it comes from Africa. And they cannot accept that a country like Madagascar, which is one of the poorest countries in the world, has discovered this formula to save the world," he added.

The World Health Organization (WHO) had warned against the use of CVO without any medical supervision and cautioned against self-medication. The WHO further said that they have not approved the concoction for the patients suffering from COVID-19.

On Thursday, the WHO, however, has called for clinical trials of CVO.

"Covid-Organics is a preventive and curative remedy against COVID-19, which works very well," said President Rajoelina.

He attributed recovery of 105 COVID-19 patients in Madagascar to the herbal potion.

"A marked improvement was observed in the health of the patients who received this remedy just 24 hours after they took the first dose. The cure was noted after seven days, even ten days. This remedy is natural and non-toxic," he said.

Madagascar has donated CVO, which is claimed to cure the COVID-19 to several African countries.

Last week, the African Union in a statement said it is talking with Madagascar to obtain technical data regarding the safety and efficiency of the herbal remedy.

South Africa allows phased reopening of tourism amid COVID-19

The South African government on Saturday announced a phased reopening of tourism, further easing COVID-19 restrictions starting from June 1.

"Based on the COVID-19 epidemic expected trajectory, the first phase of the recovery for the sector will be driven by domestic tourism, followed by regional tourism and international tourism next year," Tourism Minister Mmamoloko Kubayi-Ngubane said.

On May 24, President Cyril Ramaphosa announced that the lockdown for the whole country will be lowered from level four to level three effective from June 1, allowing more industries to resume operations and millions of people to return to work, accompanied by the reopening of schools.

Although South Africa will be gradually reopening up in the coming months, depending on how the virus is spreading, the tourism sector is expected to fully recover in the end of this year, said Kubayi-Ngubane.

The past two months of lockdown have been difficult for the tourism sector, she said.

"We continued to see many businesses in the sector fighting for survival and our projections showed that almost 600,000 jobs were at risk if the sector doesn't come into operation by September 2020," Kubayi-Ngubane said.

"As we open up the sector, we are therefore confident that measures have been put in place to protect our employees, suppliers, tourists and all those who are involved with the sector," the minister said.

BOTSWANA:

Botswana to help repatriate citizens stranded abroad

By CGTN Africa - Botswana will help repatriate citizens stranded abroad by coronavirus travel bans, with more than 100 due to arrive on Wednesday from Ethiopia, President Mokgweetsi Masisi said on Saturday.

Botswana ended a 48-day lockdown a week ago, allowing businesses and schools to reopen under strict conditions but its borders are still closed with only returning citizens and essential goods allowed in.

"In order to alleviate the plight of our citizens abroad who have been adversely impacted by the pandemic, mostly students and those affected by the global travel bans, we have decided to assist them with financial assistance to either cope where they are or to return them home," Masisi said in a televised speech.

Masisi said the government has helped 400 return from South Africa and neighbouring countries. Botswana has recorded just 35 coronavirus cases and one death.

But the economy has been severely hit, with real gross domestic product forecast to contract by 13% in 2020.

De Beers discussing temporary move of diamond sales from Botswana with Govt.

DE Beers is in discussions with the Botswana government to move diamond sales from its capital, Gaborone, nearer to buyers in international centres in order to get rough diamond trade flowing again, said Reuters.

Citing De Beers executive vice president of Diamond Trading, Paul Rowley, the newswire said the temporary shift in sales point would be done in such a way that the sales were still booked in Botswana. "If we can move our product closer to them it would give us the flexibility to restart sales as soon as the markets reopen," said Rowley.

"The temporary measure will enable us and our government partners to generate some revenue in this difficult period," said Rowley. Anglo American unit De Beers sells 90% of its total supply from Gaborone whose economy relies on diamonds, said Reuters.

But since the COVID-19 pandemic, diamond buyers from traditional centres, such as Antwerp and Mumbai, have been unable to travel to Botswana, which they previously visited ten times a year to view and buy diamonds, it said.

Movement restrictions and weaker demand forced De Beers to cancel its diamond sales, known as sights, in April and May after the February sale declined by 36% to \$551m.

The COVID-19 outbreak has come at a bad time for the diamond industry following poor trading conditions in 2019. De Beers made its smallest profit in more than a decade last year after a glut of rough and polished stones destroyed margins for the industry's crucial middlemen who cut, polish and trade them, said Bloomberg News.

HARARE, May 30 (Xinhua) -- Zimbabwe reaffirmed its adherence to the one-China policy and backed China's top legislature's decision to establish and improve the legal system and enforcement mechanisms for the Hong Kong Special Administrative Region (HKSAR) to safeguard national security, a senior official has said.

Zimbabwean Information, Publicity and Broadcasting Services Minister Monica Mutsvangwa told Xinhua on Thursday that the new law will help consolidate Hong Kong's security and stability, and protect it from Western interference.

Western countries that are obsessed with interventions always want to see people divided, Mutsvangwa said. "We are very much for the one-China policy and that is what we support as a country."

"We know the suffering when people are divided. We know China's policy toward Hong Kong has actually brought the people together as one and helped achieve the economic development," she added.

The minister said foreign intervention aimed at destabilizing Hong Kong was a "disgrace," which should be discouraged.

"Where there is unity, where there is peace. There is certainly development and so we support that law. We only hope that this foreign intervention does not continue to happen, because all that it does actually bring disunity and discord in a country and that affects the rate of development which China is moving at," she said. "We had Namibians on board that vessel and we had the responsibility to assist and ensure that those Namibians came home safely. That is what we have done. We took all the precautions that were necessary.

"It has helped us to put every precaution in place to eliminate all risks. Namibia can be rest assured that there will be no infection from this operation," he said.

According to !Hanabeb, the two groups were transported by buses that were already waiting before the vessel entered the port. The aircrafts at the Walvis Bay airport were also ready before the buses departed from the port. He said all who boarded the vessel or buses had full protective clothing and gear that consisted of masks, goggles, gloves and full body suits.

The police escorted the group to the Walvis Bay airport to avoid the risk of any of the passengers getting out of the escort. The seven Namibians and one citizen from Botswana are currently in quarantine at a local hotel for 14 days.

Angola supplied 13 percent of the crude oil China consumed last year, China National Petroleum Corp. (CNPC) says, citing an official government work report presented to the Chinese legislature, the 12th National People's Congress.

The Chinese state-owned company says the document contains figures given by the China Petroleum and Chemical Industry Federation, which indicate that China used 696 million tonnes of crude last year, 7.4 percent more than the year before.

The document says Russia was the biggest source of the oil China used last year, supplying 19 percent, Saudi Arabia was the second-biggest, supplying 15 percent, and Angola was the third-biggest.

China imports almost 70 percent of the crude oil it uses, and over 40 percent of the natural gas is uses, CNPC quotes the document as saying.

EGYPT:

Ethiopia and Egypt are pushing each other to the brink in a battle for control on the river Nile https://qz.com/africa/1862962/ethiopia-egypt-battle-for-river-nile-grand-dam-without-trump/ Addis Ababa May 31, 2020 By Zecharias Zelalem

When Ethiopia, this week, criticized the Egyptian government for its "unprincipled" stand on the Grand Ethiopian Renaissance Dam (GERD) it raised the stakes on one of the Africa's most contentious diplomatic negotiations in recent decades.

The comments came even though both states have expressed a willingness to return to tripartite talks with Sudan, over the dam. The key source of the tension with Egypt is that Ethiopia remains adamant to start filling the dam's reservoir by July.

"Instead of earnest discussion, Egypt has used the negotiation platform to demand that the dam be smaller, carry a lower volume of water, and be turned into something that wouldn't fulfill our needs," said Gedu Andargachew, Ethiopia's foreign minister speaking at a press conference with political party representatives at Addis Ababa's African Union Conference Hall on Wednesday. "It's up to them to leave this obstructive approach and instead cooperate with the parties involved."

Ethiopia's insistence on filling the reservoir without an agreement on technicalities is a major sticking point for Egypt. The dam's reservoir has a capacity of 74 billion cubic meters, and Ethiopia plans on storing around 18.4 million cubic liters of water in it in the coming two years.

Egypt says doing so without a signed agreement is a breach of international law and would dangerously impact its own water supply downstream. Ethiopia has reiterated that it doesn't need Egyptian approval to fill the dam. US officials, who Egypt had called in to help mediate, had insinuated that progress had been made, but the pair's differences were many and eventually led to Ethiopia's pulling out from a final round of scheduled roundtable talks in late February. Ethiopian officials accused the Trump administration of pressuring the Horn of Africa country to make unreasonable concessions.

"Ethiopia will never sign on an agreement that will surrender its right to us the Nile River," Ethiopia's ambassador to the US, Fitsum Arega wrote on Twitter at the time.

The diplomatic spat starts with Africa's longest river, the Nile, which runs through 11 countries. Ethiopia contributes about 85% of the Nile water flowing to Sudan and Egypt. The 11 nations are hoping that the massive Grand Ethiopian Renaissance Dam will open up many new opportunities from electric power supply, agricultural irrigation to reducing evaporation losses.

When completed, the dam will have installed capacity to generate 6,000 MW electricity to relieve Ethiopia's acute energy shortage and also export to Sudan and possibly Egypt. The dam's 74 billion cubic meters of water is about half the volume of the Aswan High Dam in Egypt.

Tripartite effort

Months into the deadlock, Sudan has lobbied to reinitiate the stagnated tripartite effort and has gotten a positive response from Cairo and Addis Ababa, despite the open bickering between the two.

US mediation had been sought by Egyptian president Abdel Fattah Al-Sisi, after Ethiopia's prime minister Abiy Ahmed agreed to the involvement of a third-party mediator. From November to February, diplomats from Ethiopia, Egypt and Sudan shuttled between Washington DC, Khartoum, Cairo and Addis Ababa. World Bank representatives were also brought in as additional arbitrators.

In November, Ethiopia agreed in principle to an Egyptian request that the dam filling process be carried out in stages over seven years. But the nitty gritty of how it would be carried out, including the speed with which the reservoir would be filled, left the two at odds.

In this regard, the US has done little to bring the opposing sides together, and Ethiopia eventually decided not to attend a final round of negotiations in late February, where the sides were supposed to sign a legal and binding agreement. Ethiopia rejected terms of a deal it deemed favorable for Egypt, which led to accusations by Ethiopians that the US was trying to coerce Ethiopia into compromising on its dam aspirations. Ethiopians in the US took to the streets to protest "US pressuring of Ethiopia."

Egypt meanwhile, took issue with Ethiopia's absence from the final round of talks, and of its refusal to sign the agreement which had actually been drafted by US and World Bank mediators. In a letter penned to the United Nations Security Council earlier this month, Egypt's foreign minister Sameh Shoukry decried Ethiopia's "unilateralism, its lack of willingness to cooperate and its desire to fill the GERD regardless of the impact on downstream riparians."

While the text of the treaty that American mediators hashed out isn't publicly available, Shoukry gave a briefing of what it entailed in his letter to the UNSC. Among the clauses Ethiopia found unacceptable according to Shoukry, a compromise which included "mitigations measures," which would be implemented even beyond the first stage filling period, if Egypt were to experience drought.

Ethiopia brands this as nefarious. "On the Egyptian side, negotiations until now were hindered by Egypt's desire to maintain its historical hegemony," said Dr. Seleshi Bekele, Ethiopia's minister of Water, Irrigation and Energy. According to the minister, dam construction progress currently stands at 73.7%

Sudan has shown a determination to de-escalate tensions, with prime minister Abdullah Hamdok believed to have arranged the continuation of tripartite talks by communicating with his Ethiopian and Egyptian counterparts in recent weeks. China has also lobbied the two to put and end to the spat and work towards peaceful resolution. Beijing's interest likely stems from its financial support for the GERD project. Two Chinese state companies were awarded \$150 million in GERD construction contracts last year.

But with Ethiopia's Abiy telling Ethiopians that "not even the coronavirus" would hamper dam plans, and Egypt's heavy-worded message to the UNSC, it would seem the impasse could be on the brink of deteriorating even further, come July.

Egypt orders the wearing of face masks in public

Prime Minister Mustafa Madbouly said violators will be fined. He said the nationwide curfew will be 8 p.m. to 6 a.m. for another two weeks.

Infections in Egypt rose this week during Eid Al-Fitr celebrations, at the end of the holy month of Ramadan. The country of 100 million people has the highest announced deaths from COVID-19 in the Arab World.

On Friday, Egypt registered 1,289 new coronavirus cases and 34 deaths, marking another record of daily increases on both counts despite stricter curfew rules.

That brought the total number of fatalities to 879 and confirmed cases to 22,082, of which 5,511 people have recovered.

Ethiopia's Minister of Water, Irrigation and Energy, Sileshi Bekele, and Morocco's Minister of Energy, Minerals and Environment, Aziz Rabbah, recently discussed perspectives for bilateral cooperation between their two countries in the field of renewable energy.

Ethiopia, an East African country, and Morocco, a North African country, plan to strengthen their partnership in the field of renewable energy. To this end, Ethiopia's Minister of Water, Irrigation and Energy, Sileshi Bekele, and Morocco's Minister of Energy, Minerals and the Environment, Aziz Rabbah, have scheduled a virtual meeting on May 22, 2020.

The authorities of the two countries discussed the possibilities of accelerating the implementation of the Coalition for Sustainable Energy Access, in order to improve the capacity of the electricity sector. Ethiopia and Morocco formed the coalition at the UN Climate Action Summit in September 2019 in New York, United States. The initiative aims to ensure 100 percent access to electricity in least developed and developing countries by 2030.

Ethiopia and Morocco have recently made great strides in the renewable energy sector. Currently, several projects are under way in both countries. In Ethiopia, the latest is an ongoing project to install 25 mini-hybrid mini-grids financed by the African Development Bank (AfDB). This project aims to provide access to electricity to all Ethiopians by 2025.

Morocco, for its part, aims to increase the share of renewable energies in the energy mix to 52%. The country has the necessary resources to meet this challenge. According to a recent report on emerging offshore wind markets, carried out by the World Bank's Energy Sector Management Assistance Programme, Morocco has — in addition to its solar resources — a "fantastic" offshore wind resource "too attractive to ignore". US considers sending training unit to Tunisia amid North Africa tensions

The United States said it is considering deploying a Security Force Assistance Brigade in Tunisia for training, as part of its assistance program with the North Africa country, amid concern over Russian activity in Libya, Reuters reports.

Libya's civil war has drawn in regional and global powers, prompting what the United Nations has called a huge influx of weapons and fighters into the region, in violation of an arms embargo.

"As Russia continues to fan the flames of the Libyan conflict, regional security in North Africa is a heightened concern," the US Africa Command said in a statement on Friday.

"We're looking at new ways to address mutual security concerns with Tunisia, including the use of our Security Force Assistance Brigade."

It later said the Brigade refers to a small training unit as part of military assistance and no way implies combat military forces.

Russian military personnel have delivered 14 MiG 29 and Su-24 fighter jets to the Libyan National Army's (LNA) Jufra air base, the US military said on Wednesday, despite denials by the LNA and a Russian member of parliament.

Egypt, Russia and the United Arab Emirates support the eastern-based Khalifa Haftar's LNA, which launched an offensive last year to seize the capital Tripoli.

In a statement, Tunisia's defense ministry said the US was a main partner in the effort to build its army's operational capability.

Hundreds of Tunisians take to streets of several cities to demand jobs worst economic crisis in more than 60 years due to coronavirus pandemic.

TUNIS - Hundreds of Tunisians protested on Thursday in at least seven cities to demand jobs, heaping pressure on a government facing the worst economic crisis in more than 60 years due to the coronavirus pandemic.

In the southern city of Gafsa, a witnesses said hundreds of university graduates gathered in front of the state headquarters, chanting slogans such as "we need jobs".

Hundreds more protested in Hajeb El Ayoun and Sidi Bouzid, witnesses said. Smaller protests by unemployed people also broke out in the cities of Beja, Kasserine, Tozeur and Sfax, state news agency TAP said.

Even before outbreak hammered Tunisia's tourism sector, which accounts for nearly 10% of gross domestic product, successive governments since the uprising of 2011 have failed to resolve stubbornly high inflation and unemployment that has bred discontent especially among young people.

On Wednesday, a company official told Reuters said protesters calling for jobs brought Tunisia's phosphate output to a halt by staging sit-ins at state-run Gafsa Phosphate (CPG), the country's sole producer. Phosphate is a key source of foreign currency.

The official unemployment rate is 15.3% but looks certain to rise.

Tunisia started relaxing restrictions on movement and businesses this month, allowing 75% of government employees to return to work - but the authorities expect the economy to shrink by 4.3% this year, which would be its steepest contraction in more than 60 years.

The country has so far recorded 1,068 confirmed cases of the coronavirus and 48 deaths.

The birthplace of the Arab Spring, Tunisia is the only country to achieve a peaceful transition to democracy following the 2011 revolts that swept autocrats from power across North Africa and the Middle East.

Libyan government ready to sit down to reach cease-fire, but not warlord Haftar, says senior US diplomat

ANKARA After over a year of attacks on Libya's government, warlord Khalifa Haftar is not showing any flexibility towards reaching a cease-fire, according to a senior US diplomat.

In an interview with France 24 on Thursday, David Schenker, the US assistant secretary of state for Near Eastern affairs, said the Libyan government has demonstrated some flexibility toward returning to the negotiating table, but Haftar's side has not.

Saying that the US supports an immediate cease-fire, Schenker added that Secretary of State Mike Pompeo spoke last Friday with Fayez al-Sarraj, the prime minister of Libya's government, also known as the Government of National Accord (GNA).

Pompeo "expressed to him the need to return to negotiations as quickly as possible to accept the cease-fire. We believe that the GNA is demonstrating some flexibility, but not so for the LNA [so-called Libyan National Army] and Haftar," Schenker said.

He added that what is going on in Libya is a regional conflict far beyond a proxy war and that an arms embargo should be implemented to restart the negotiation process.

Schenker warned that the Libyan conflict "could spin out of control if the Russians choose to escalate further," adding that the US is extremely concerned with the deployment of advanced Russian jets to the country.

Similar dynamics in Libya, Syria

Comparing developments in Libya to Syria's decade-long civil war which has killed, injured, or displaced millions of civilians, Schenker said what Russia and the Syrian regime have done in Syria "resembles a genocide" and "similar dynamics are playing out" now in Libya.

He said the US has adopted the Berlin plan for Libya and is still committed, despite its poor implementation to date. He added that the US is helping Libya by sending it funds for battling COVID-19 and engaging in diplomacy among regional actors.

The Berlin plan, reached at a conference this January in the German capital, agreed to new steps to support the cease-fire and observe the arms embargo.

Speaking at the end of the conference that brought together world powers and regional actors, including Turkish President Recep Tayyip Erdogan, German Chancellor Angela Merkel said all the participants agreed that there could be no military solution to the Libyan conflict.

The Libyan government has been under attack by Haftar's forces since April 2019.

While France, Egypt, Russia, and UAE support Haftar, directly or indirectly, Turkey has shown solidarity with the UN-recognized, legitimate government representing the will of the Libyan people.

Following the ouster of late ruler Muammar Gaddafi in 2011, Libya's new government was founded in 2015 under a UN-led political agreement.

Haftar's illegal forces in eastern Libya have launched numerous attacks to capture Tripoli, the nation's capital, with more than 1,000 killed in the violence.

The United Nations' Libya mission has frequently expressed concern over the civilian causalities caused by Haftar's forces.

In early May, the United Nations Support Mission in Libya (UNSML) said it was "very concerned by the continued indiscriminate attacks and targeting of civilians in civilian populated areas and the increase in civilian casualties from the use of rockets and artillery, as well as from targeted killings by forces affiliated to the 'Libyan National Army' (LNA)."

Turkey and Russia Are at War, and Libya's the Loser

The failed siege of Tripoli is an opening for peace, but only if the outside players end their proxy war.

The long-running Libyan civil war appears to be staggering toward a finale. In recent days, the forces of General Khalifa Haftar, who controls the marginalized east and south of the country, have been forced to withdraw from their stalled offensive against the capital, Tripoli. It is a triumph for the internationally recognized Government of National Unity, led by the elected prime minister, Fayez al-Sarraj.

But the fighting is not simply a domestic issue — Libya's civil war has become a proxy for regional and global power geopolitics. It is also a legacy of the way in which the West abandoned the country a decade ago.

The Tripoli government is supported strongly by Turkey, while Haftar's coalition is backed by Russia, Egypt, the United Arab Emirates, France and a smattering of other nations operating clandestinely. Haftar's defeat may be an opening for a negotiated settlement, but it will require those outside nations to push the warring sides to the table. The U.S. and European Union also have a role to play.

Libya has Africa's largest oil reserves, but production has cratered to almost nothing from over 1.6 million barrels daily before the fall of the dictator Moammar Al Qaddafi a decade ago. All of this could have been avoided. Libya also has gorgeous beaches and an educated, middle-class population; it could have become a kind of "Dubai on the Mediterranean." But it all fell apart in 2011. As supreme allied commander of the North Atlantic Treaty Organization, I oversaw a significant Western intervention following Qaddafi's threats to destroy the eastern city of Benghazi and create "a river of blood," as his son Saif put it. The United Nations Security Council passed resolutions calling on NATO to set up an arms embargo from the sea, a no-fly zone in the air, and to take all necessary combat measures to stop the dictator under the international legal doctrine of "responsibility to protect."

The NATO coalition I led was joined by many Arab nations in close support, including Egypt, Saudi Arabia, Jordan and the U.A.E. Our mission was not to overthrow Qaddafi per se. But his regime was weakened by NATO efforts, including a precise bombing campaign. The rebellious population eventually overthrew him, and he was brutally killed by a mob.

At that moment, unfortunately, the resolve of the West was weak. NATO, its military mission complete, withdrew. I looked with disappointment at the EU and the rest of the global community refusing to remain and stabilize the situation. Libya descended into the chaos it still suffers today. The ancient animosities inside the country are largely tribal at heart, and rooted in resentments between the relatively wealthier west and the oil-poor east and south.

In the aftermath of the NATO intervention, I met with Haftar, a dual Libyan-U.S. citizen who lived near Washington for years. I was impressed with his energy and drive, and hoped he could be part of resolving the tensions in the country after the NATO mission departed.

But as the civil war has dragged on since 2014, Haftar has led a campaign to dominate the country militarily, leading nations from across the region to intervene either for or against him. Turkey has been particularly engaged, throwing its support behind the Tripoli government. Russia joined the Arab states supporting Haftar, sending in a comically inept mercenary force, the Wagner Group, to try and swing events in the general's favor. The mercenaries were ignominiously airlifted out this week, but Russian air power is reportedly being deployed in support of Haftar's troops.

Nonetheless, the Tripoli government sounds increasingly confident in its ground game, and Turkish air power (including sophisticated drones) is having strong effect. The whole thing is an echo of the so-called Great Game the British and Russians waged in Central Asia in the 19th century, but now playing out in North Africa.

All of this occurs as the coronavirus spreads across the region and many global powers, including the U.S., are highly distracted. Yet there have been thousands of deaths and more than 200,000 people displaced from their homes in the last year alone. More fighting will also mean more illegal migration north to Europe over dangerous sea routes.

The U.S. hasn't been totally AWOL. In late January, Secretary of State Mike Pompeo attended an international conference in Berlin that sought to push the warring sides toward negotiations. But Turkey and Russia, motivated by oil wealth and regional leverage, never reached a deal. Now, perhaps, the setbacks to Haftar's forces will reopen a chance for peace.

For the U.S., the best course is to partner with the EU to restart talks somewhere in Western Europe. They should press Turkey, a NATO ally, to negotiate with Russia on each reducing military support; aim to get agreement from the Gulf Arabs (who no longer have teeming oil wealth allowing them to

intervene abroad) and Egypt to let the Libyans sort it out internally; help build a cease-fire that could restart the oil production; and provide humanitarian assistance in containing the coronavirus. Losing a brutal dictator only to fall into a decade of war has been a sad outcome for the 6 million Libyans. For the U.S. and Europe, helping them find a path to peace is not just a humanitarian imperative — it is a direct responsibility, given the dire way in which the 2011 NATO intervention turned out.

of migrants," the statement said.

Senegal reports 71 new confirmed cases of COVID-19

Senegalese Ministry of Health and Social Action reported on Sunday 71 new confirmed cases of COVID-19, bringing the total number of cases to 3,047 in the country.

These 71 new infections came from 889 tests done in the past 24 hours, health ministry Abdoulaye Diouf Sarr said.

For the second consecutive days, there is an imported case detected by the ministry, while the number of new community transmission cases are dropping to 4.

He also announced that 40 more patients were cured, bringing the total number of recovery cases to 1,456.

The ministry also confirmed the death toll rose to 35 in the country.

Senegal is celebrating the end of the Ramadan month this weekend. The government and some spiritual leaders have invited the population to unite with their families through phones and internet in order to avoid travelling between regions, given the serious situation of community transmission spreading.

Senegal is in state of emergency until June 2, with a curfew imposed from 9 p.m. to 5 a.m. It is also mandatory to wear masks at all public places.

Senegal to re-open mosques, ease restrictions as coronavirus cases jump

Senegalese President Macky Sall announced the re-opening of mosques and churches and the easing of other restrictions imposed to contain the coronavirus, even as the largest one-day jump in cases was recorded on Monday.

Sall ordered places of worship closed in March and imposed a dawn-to-dusk curfew. Since then, the daily pace of new cases has picked up, 177 on Monday from a previous high of 104, with increasing community transmission in hotspots such as the holy city of Touba.

Senegal has recorded 1,886 coronavirus cases in total, including 19 deaths.

Sall, like other leaders in West Africa, has confronted public pressure to find more sustainable ways to balance public health with economic realities in the face of an epidemic that the World Health Organization (WHO) has warned could drag on across Africa for years.

"In the best of cases, COVID-19 will continue to circulate in the country until the month of August, or even September," Sall said in an address to the nation. "In this new phase that will last not a few weeks but three or four months, we need to learn to live in the presence of the virus."

Sall also said the 8 p.m. to 6 a.m. curfew would be shortened by one hour in the morning and one hour in the evening and that weekly markets could re-open.

Several other West African governments, including Burkina Faso and Ghana, have announced a similar easing of restrictions this month, while calling on their citizens to wear masks and practice social distancing.

BURKINA FASO:

Attack in northern Burkina Faso kills at least 15

The attack, carried out by an unidentified group of assailants, left several others wounded. Many more were still unaccounted for, the government said in a statement.

Burkina Faso has been battling armed combatants with links to Al- Qaeda and the Islamic State since 2017.

Hundreds have been killed in the past year in the Sahel nation, and over half a million people have fled their homes due to attacks which have also fuelled ethnic and religious tensions.

On Thursday, Burkina Faso's armed forces said troops destroyed a militant camp in another province in the north of the country. It said 10 assailants and a soldier died during the operation.

Ivory Coast army joins Burkina Faso in anti-jihadist operation

Soldiers from Ivory Coast and Burkina Faso conducted their first joint operation against active jihadists near their shared border, killing eight suspected militants and arresting 14 others, Ivory Coast's army said on Sunday.

Burkina Faso and its neighbours Mali and Niger in West Africa's semi-arid Sahel zone are battling Islamist insurgencies with links to al Qaeda and Islamic State.

Those groups have been strengthening and expanding their range of operations, leaving coastal countries like Ivory Cost fearful the violence will spill onto their territories.

The joint operation was launched on May 11 with about 1,000 Ivorian soldiers participating from their side of the 580-kilometre (360-mile) border with Burkina Faso, Ivory Coast's army said in a statement.

The suspected militants were killed in Burkina Faso, the army said, adding that the operation is ongoing.

Jihadist attacks in Burkina Faso, Mali and Niger have escalated dramatically over the past year despite significant military support from former colonial ruler France.

While Ivory Coast has mostly been spared the violence affecting its neighbours, it was the victim in 2016 of an attack claimed by al Qaeda in which gunmen killed 19 people at a beach resort.

Benin holds local elections despite COVID-19 threat

Benin held its local elections on Sunday minus some opposition parties amid the global COVID-19 pandemic.

The West African nation earlier this week lifted a raft of restrictions aimed at curbing the spread of the disease.

The country has registered 339 infections and two deaths, according to the U.S.-based Johns Hopkins University.

The national election authority (CENA) made face masks mandatory for voters and enforced social distancing at the polling stations.

Campaigns leading to the vote were limited to posters and media appearances as candidates were forced to cancel their rallies due to a ban on gatherings of more than 50 people.

Critics however warned that the health risks of holding the election were too high.

Benin, seen as one of the region's most stable democracies, has been in political crisis since a disputed parliamentary poll last April sparked protests.

Opponents of President Patrice Talon called on their supporters to boycott the polls over the COVID19 outbreak and the political situation.

Reports indicate a low voter turnout.

Final results from the election are expected within a week.

How oil companies evade over N258b gas flare penalty yearly

There are indications that oil companies operating in the country may be evading gas flare penalty, and this development has led the country to losing as much as N258b yearly, which would have accrued after a review of fiscal penalty, fine of \$3.50 per 1, 000 standard cubic feet (scf) of gas flared.

This development is fueled by growing under-reporting of flared gas across fields, as evidenced by discrepancies in figures reported by different agencies and independent bodies, which are monitoring the menace in the Niger Delta.

Facility for Oil Sector Transparency and Reform in Nigeria (FOSTER) and the African Initiative for Transparency, Accountability and Responsible Leadership (AfriTal), recently alleged that oil producers since 2018 have been deliberately under-reporting the level of gas flare.

Indeed, figures from the Nigerian National Petroleum Corporation (NNPC), which operates joint venture deals with most of the oil companies were also under-reported, as a World Bank-supported Gas Flare Tracker (GFT) reported figures almost double of what the state-owned oil company currently reports.

While GFT has been handed over to the National Oil Spill Detection Response Agency (NOSDRA), its satellite-generated data is reportedly safe from manipulation as it collects information on gas flare in oil fields across Nigeria every 24 hours, and sums them up every month.

For instance, the NNPC's data in 2018 showed that Nigeria flared 282 billion standard cubic feet (scf) of gas, a 10 percent of the total gas produced in the country within the period under review, but GFT reported 472.4bcf of gas for the same year.

Similarly, while the Nigerian Gas Flare Commercialisation Programme (NGFCP) showed that Nigeria flared 325bscf of associated gas in 2019, representing 11 percent of gas produced in the country, GFT recorded 475bscf as gas flared for the same year.

The implication is that about 190 bscf was not reported in 2018, while 150bscf was under-reported in 2018. With a fine of \$3.50 per 1, 000 scf, as much as \$665m (N257.9b) would have been paid in 2018, if the guidelines for the 2018 reviewed fiscal penalty, which moved payment from 50 cent to \$3.50 per 1, 000 standard cubic feet (scf) were applied. A development counted as tax evasion by some stakeholders.

While the situation is projected to worsen challenges faced by the Federal Government's attempt to ensure zero gas flaring latest by 2020, the Associated Gas Re-Injection Amendment Decree Seven of 1985 introduced a two kobo per million standard cubic feet (mscf) as punishment for gas flaring, which was later increased to 50 kobo in 1990. It was N10 per Mscf in 1998 as a Ministerial Directive in 2011 proposed \$3.50 per 1000 scf, but became effective in 2018.

Coming at a time that the Federal Government said that gas flare penalty payment by oil and gas companies in would increase to N103.51bn this year, little did the government know that it was allegedly being swindled by producers operating in the country.

An expert with the Stakeholder Democracy Network (SDN), Jesse Martins Manufor had said: "Since 2013 when the GFT was launched, data from the tracker significantly matched that of the volumes declared by the oil and gas companies in the records of NNPC up until 2017. However, there has been a significant variation in volumes in the NNPC's 2018 and 2019 data as compared to the GTF.

"This might be as a result of gas flare regulations introduced in 2018, which impose an increase in the fines to be paid for gas flaring. Prior to 2018, it made more sense to flare and pay a penalty of 50 Cent because there was no stringent enforcement. However, with the increase in the penalty to \$3.50 for companies producing more than 10, 000bpd, the new regulation might be responsible for the discrepancies," he suggested.

An energy expert, Madaki Ameh, who said the development amounts to tax evasion by the IOCs, noted that the companies were deliberately adopting environmental standards different from what obtains in their countries, or elsewhere in the world where they operate. This, he said, was due to the country's lax and compromised regulatory environment.

He insisted that loses by the government from the crime remains huge, adding that, "tax evasion has always been a crime. The Federal Internal Revenue Services (FIRS) must set up an oil and gas industry-specific crack team to monitor infractions and bring perpetrators to book in line with extant laws."

While a series of report by Nigeria Extractive Industries Transparency Initiative (NEITI) had in the same vein alleged discrepancies in extracted crude oil, as well as revenue remittances by oil firms, a foremost environmental activist and Director of Health of Mother Earth Foundation, Nnimmo Bassey, insisted that the poor reporting of gas flare was more of an unwillingness to measure the amount of gas being flared, rather than an inability.

Bassey stressed that there were perverse factors inhibiting the measurement of the amount of oil and gas produced, and the amount of gas flared as well, adding that it was regrettable that the NNPC holds the biggest shares in the various JV agreements, yet the oil majors are the operators and they determine the production cost of oil in Nigeria.

"Is it surprising that production cost of a barrel of oil in Nigeria is one of the highest in the world? The production costs go to the producers. The JV shares the profit. Gas flaring fines are paid by the JV partners. Do you see the perversity in the arrangement? It is impossible for the government to come down hard on the companies. They are inextricably connected in the business.

"That incestuous relationship has to be dissolved and reorganised through appropriate legislation. Making such a law has so far been impossible, possibly due to vested interests. The law must determine that the producer will pay such fines outside any regime that affects the revenue accruing to the other JV partners," he said.

For the National Coordinator, National Coalition on Gas Flaring and Oil Spills in the Niger Delta (NACGOND), Dr. Edward Obi, the reason why there are discrepancies in the figure of gas flare is because oil companies perhaps, are unwilling to pay the new penalty rate.

He said: "Now we noticed a huge drop the in the amount of gas flare in the data that is supplied from the time that government reviewed this penalty to now. And the discrepancies is so much that they are reporting just about half of what they are flaring, which is unfortunate. I think they are trying to avoid the penalty cost. But the Department of Petroleum Resources (DPR), which should be on the side of government should not accept those figures and present them to government like that," he said.

Obi observed that whereas human beings can be influenced by their personal interest in the oil company, reports from a satellite that is completely detribalised, depoliticised, dissocialised, and that is as abstract and objective as possible should be the best method to measure data of gas flared from the Niger Delta.

"The government should question the DPR, which is not giving it accurate figures of the gas flare. The government should ask, 'why are you accepting what the oil companies present to you? Why are you not confirming if this is same as what an independent satellite is confirming or not? There should be somebody independent in government who should be able to raise those questions," he said.

He wondered why the DPR (if it is really working independently for the Federal Government), has not deemed it appropriate to investigate discrepancies in the Gas Flare Tracker data and those now being provided by the oil companies.

With the drop in the global price of oil due to the COVID-19 pandemic, Obi urged the Federal Government and the Ministry of Finance and everybody else that wants money into the federation's coffers to demand that oil companies pay government what is due to her.

The Kaduna Police Command has urged media houses to seek clarifications from appropriate authorities on reports regarding purported attacks and killings in Southern Kaduna by armed herdsmen, saying the full weight of the law would be brought down on fake news in the state.

A statement by the state Police spokesman, ASP Muhammed Jalige, yesterday, said journalists who promote fake news would be arrested and prosecuted. The statement came on the heels of comments attributed recently to the National President of Adara Development Association, Dio Maisamari, over attacks and killings by armed men in Southern Kaduna communities.

Jalige Said: "The attention of the Kaduna State Police Command has been drawn to a fake and maliciously fabricated story being circulated on social media, purportedly issued by the National President of Adara Development Association dated May 28, 2020 captioned, 'Again, Fulani Herdsmen Attacked Southern Kaduna Communities,' in which the writer reported that there were fresh attacks on some communities in Kajuru Local Government, where he claimed that from January to May, 2020 people were killed, with many injured and displaced from their homes."

Jalige recalled that the Command had confirmed two unfortunate incidents of attack on Gonar Rogo and Unguwan Arha communities in Kajuru area of Kaduna State on May 12 and 13, 2020 by unknown gunmen, which regrettably led to the unjustified killing of 27 innocent persons.

He said: "The Command, therefore, wishes to categorically debunk the story in its entirety as fake and deliberately disseminated to create fear and apprehension in the minds of peace loving people of Kaduna State and Kajuru in particular.

"The authority is saddened by the recent attacks on some communities in Kajuru, although relative peace has been restored. It would not fold its hands to watch certain individuals, whose aims and objectives (yet unknown), are tantamount to truncating efforts of the Police, other sister security agencies and Kaduna State Government in ensuring that lasting peace returns to the affected areas, by making unnecessary inflammatory statements and raising frayed nerves..."

Can President Buhari fight corruption without support of judiciary?

https://guardian.ng/politics/can-president-buhari-fight-corruption-without-support-of-judiciary/ Under the miasma of Covid-19, the Nigerian Supreme Court managed to dish out another questionable judgement. If their justices reached their recent decision in UDE JONES UDEOGU V. FEDERAL REPUBLIC OF NIGERIA & others, SC/622c/2019 under the impression that Nigerians have been discombobulated by Covid-19, they have mistaken. Majority of Nigerians are unaffected by the disease and a number have protested their latest controversial decision. Their justices' skilled sleight of hand is fast gaining them notoriety in the country, they need to put them in check. Their reputation and integrity are now in disrepute.

On 8 May 2020 in the case mentioned above, otherwise known as the ORJI UZO KALU'S case, the Supreme Court quashed the conviction of Orji and his co-accused for monumental corruption and gross abuse of power. The Supreme Court in its judgement read by Justice Ejembi Eko, held that the lower High Court and trial judge Justice Mohammed Idris that convicted Orji lacked jurisdiction, at the time the conviction was secured. In the Supreme Court's opinion, the trial judge having been elevated to the position of Justice of the Court of Appeal before concluding the trial, ought not have returned to complete the case he had almost completed which had dragged on far too long due to the theatrical artifice of the accused. Perhaps, at this point it is important to state three key features of the case that incensed those criticising this judgement. First, it was the appellant, Orji's co-accused who requested that the trial judge be given the permission to complete the case. Second, the trial judge was given the expressed permission by the president of the Court Appeal to return and conclude the case. Third, and of huge significance, the President of the Court of Appeal gave the permission to Justice Idris in reliance and in accordance with Section 396 (7) of the Administration of Criminal Justice Act, 2015. S.396 (7) of ACJA as has been copiously quoted and states "

Notwithstanding the provision of any other law to the contrary, a Judge of the High Court who has been elevated to the Court of Appeal shall have dispensation to continue to sit as a High Court Judge only for the purpose of concluding any part-heard criminal matter pending before him at the time of his elevation and shall conclude the same within a reasonable time: Provided that this subsection shall not prevent him from assuming duty as a Justice of the Court of Appeal ''.

Even for a lay mind, S.396(7) of ACJA could not have been expressed in a more succinct ordinary English language. Due to its clarity in word and intent, I urge a reader to underline every sentence in S.396(7) ACJA, 2015 to appreciate it. Yet, despite the wording and the clear purpose of that Legislative Act, the Supreme Court in its wisdom in the instant case nullified the Act. This is because of its apparent inconsistency with the Ss. 290, 252 and 253 of the Nigerian constitution 1999.

The Supreme Court said that by going back to finalise the case in the High Court, Judge Idris was wearing two hats simultaneously; that is being a Judge of the High Court and Justice of the Appeal Court to which he had been elevated to, at the same time. This assertion would be correct if, a) he was hearing two new cases at the same time – a trial in the High Court and an appeal in the Court of Appeal and/or, b) if the Orji's case in the High Court was not almost concluded. The fact, which the Supreme Court ignored is that in Nigeria, in corruption cases the accused regularly deployed dubious tactics to frustrate their trials, often with the consent of judges. It is a known fact that cases, particularly those connected to political officer holders involving huge sums of money drag on painfully slow and in most instances aborted.

The duty of the Supreme Court to strike down a legislative law that conflicts with the Constitution is an established legal principle. This is to be found in an earlier case in United States of America from where Nigeria borrowed its current Constitution and system of government. In the landmark case – MURBERY V. MADISON (1803), the USA Supreme Court held, that it has not only the duty to interpret the Constitution but also the power to review and strike down any contrary section of a legislative/administrative law to the Constitution. Therefore, stating the supremacy of the Constitution over other national laws. This is what the Nigerian Supreme Court has reinforced in Orji's case. However, what is worth noting and more relevant for this discussion is the comment of the same American Supreme Court in McCULLOCH V. MARYLAND (1819), where the Chief Justice said, "a constitution that attempted to detail every aspect of its own application would partake of the prolixity of a legal code, and could scarcely be embraced by the human mind, its nature, therefore requires that only its great outlines should be marked, its important objects designated, and the minor ingredients which compose those objects be deduced from the nature of the objects themselves". Simply put, judges should not expect that the constitution should have foreseen and captured all eventualities. The legislature has implied powers to do that which the constitution failed to do. The judges are themselves not expected to be slavish to the Constitution. ETC ...

Ghana: up enforcement to avoid EU money-laundering blacklist

Raising the game on enforcement is the only way for Ghana to escape the EU's money-laundering blacklist.

The EU Commission said on 7 May that Ghana is among 12 countries which now pose "significant threats" to the EU's financial system, due to deficiencies in anti-money laundering and counter-terrorist financing strategy.

"The key challenge, as with most legal matters in Ghana, is enforcement," says Elikem Nutifafa Kuenyehia, a Ghanaian lawyer and entrepreneur in Accra. Kuenyehia says that while lawyers are supposed to file suspicious transaction reports, he has not come across a single report showing this has ever happened.

The same applies to estate agents, he says. "It does not seem that there is any motivation for such persons to report possible money-laundering activities."

Blacklisting is subject to approval by the European Parliament and would come into force in October.

Being on the blacklist won't make it impossible to do business with these countries. But it will make it harder and more time-consuming.

Banks and other financial institutions will have to apply extra checks, leading to delays in transactions.

Botswana, Mauritius and Zimbabwe were the other African countries added to the list.

Kuenyehia fears a significant reputational impact for Ghana.

"A lot of businesses and governments in the EU would be uncomfortable dealing with businesses from countries which may create future complications for them under EU law," he says. "There are some investors who will not look at any country that feature on any kind of blacklist."

Regulatory bodies need to do more to compel compliance, which may require enhancing their capacity, Kuenyehia says. The Bank of Ghana and the Financial Intelligence Centre are the two main institutions that are leading the fight, but more regulatory institutions should be empowered to assist, he argues.

Ghana's daily infection rate slightly decreasing - Dr Badu Sarkodie

Dr Badu Sarkodie, the Director of Public Health, Ghana Health Service (GHS), on Thursday said although the country's daily rate of new COVID-19 infections are decreasing, the curve is not sharp enough.

He said while some earlier hotspot areas such as Tema, Lower Manya and Obuasi districts have not record new cases of coronavirus (COVID-19) in the past week, three other hotspots have sprang up within the same period, pushing the infection curve slightly upward.

He attributed this to the fact that people were still not adhering to the preventive etiquettes and safety protocols, and advised the public to be more responsible and supportive in their behavior towards the fight against the spread of the virus in their communities.

Dr Sarkodie, who was giving Ghana's situational update of the COVID-19 pandemic at the Minister's press briefing in Accra, said official data by the GHS as at May 26, 2020 indicates that there has been 186 new infections from 31 districts in four regions since its last update on Tuesday, May 25.

He said the country's current test positivity rate is 3.56 per cent, with a cumulative total of 7,303 positive cases, 2,412 recoveries and 34 deaths.

He said this leaves the total number of active cases at 4, 857 persons, who are being managed in treatment sites, isolation centres and other home management situations; and out of these 14 were severe, but not on ventilators and three were also critically ill.

Giving details on the district update of the new cases recorded, he said, although in the Greater Accra Region 18 districts new cases, those with significant numbers were Ablekuma -47, Ayawaso East-36, Ayawaso North-11, Korle Klottey-13, and Okaikoi-six, with the remaining districts contributed about five cases or less each, while Tema metropolis also recorded four new cases.

He explained that all of them were districts who had already recorded cases and were being managed by health authorities through the existing measures, including aggressive contact tracing,

treatment, isolation and intensive public education on the hygiene and safety protocols among others.

Dr Sarkodie said districts in the Eastern Region including the Akuapem North and South respectively recorded new cases, while in the Central Region, Cape Coast, Mfantseman, Abora Dunkwa and Upper Denkyira also had new record of infections.

In the case of the Ashanti Region six districts recorded new cases and these were made up of the Kumasi Metropolis-four, Amansie West- one; Kwabre East- one; Effigya Kwabre South-one; Ejisu- one and Oforikrom-one, but Obuasi metro did not record any new cases.

He said the three new hotspots involving Obuasi, Lower Manya Krobo and Tema districts which previously spiked the number of new infections did not record any cases this time, meaning the various measures including aggressive tracing, testing, isolating, and managing cases were working. Dr Sarkodie said ongoing actions included engagements with all stakeholders including religious organisations, Ministry of Education, Ghana Football Association and providing them with the technical support needed for to develop their own risk communication guidelines for education.

Again, enhanced surveillance, contact tracing, testing and treatment were also ongoing.

He appealed to all citizens to remain committed and disciplined in enforcing the various hygiene and safety protocols which included social distancing, wearing of face masks and regular handwashing with soap under running water, or use of alcohol-based hand sanitizers.

Cameroon urges citizens to take part in COVID-19 battle

Cameroon's president on Tuesday called on all citizens to get involved in the fight against COVID-19 pandemic that has killed 140 people in the Central African country.

"I strongly urge all political, religious and opinion leaders, all officials of associations, all traditional rulers and all dignitaries to fully participate in the fight against COVID-19," Paul Biya said.

"I, therefore, call on each and every one of you to get involved," Biya said in a televised speech ahead of the country's national day celebrated on May 20 each year.

He said that it was important to observe coronavirus preventive measures such as wearing face masks, social distancing, and frequent hand washing.

"Under these circumstances, it was not possible to maintain the festivities marking the celebration of our national day due to the gatherings it entails," he said.

"This is crucial for the health of everyone," he emphasized.

"I also wish to hail the courage of the Cameroonian health professionals and those assisting them," Biya said. "With the resources available to us, they are doing the utmost best to treat those infected with the virus."

The Central African country has so far confirmed 3,529 coronavirus cases, with 140 death and 1,567 recoveries, according to data from the US-based John Hopkins University.

Due to the coronavirus pandemic and the need to respect social distancing measures, the president of the republic has decided to cancel the public celebrations of the 2020 edition of the national day, Victor Tchatchouwo, Cameroon's ambassador to Turkey, said in a statement on Tuesday.

The ambassador also wished "a pleasant national day to all the members of the Cameroon community in Turkey."

Cameroon Military Acknowledges Soldiers Arrested in Togo

YAOUNDE - Cameroon's military says three of five men recently arrested by Togolese police and portrayed by Togolese media as notorious criminals who committed serious offenses against Togolese citizens are Cameroonian soldiers, while the other two are former convicts. The three military men stole weapons from the military headquarters in Yaoundé and went to Togo's capital, Lomé, where they used the weapons to harass Togolese, according to Togolese police.

Cameroonian military spokesperson Atonfack Guemo says investigations by the military indicate that Ntanga Clement Didier Mogo, Oumarou Abdou Fadil and Ewoundjo Elle Serge Hubert, who were arrested in Lomé for robbery and harassment of civilians, are notorious, dangerous and dishonest members of the Cameroon military.

He says Cameroon has started disciplinary and administrative proceedings against the men as provided for by military regulations and that Togo should punish them as its law provides. He says Cameroon's Defense Ministry denies responsibility for their crimes and atrocities because the men in question have broken off links with Cameroon's military.

Guemo said the other two men arrested in Lomé are civilians with criminal records and were wanted. He said the five arrested in Togo were helped by another military officer, Essimbi Francis, who has been arrested for his role in other crimes and is being held in Yaoundé.

Togo media reported May 20 that the five Cameroonians had been arrested in Lomé after using weapons to rob a Togolese businessman of his car and money.

Cameroonian media reported that Yendoube Douti, head of the Lomé research and criminal investigation unit of the Togolese police, said the five men confessed they were using weapons they obtained from the Cameroon defense headquarters in Yaoundé.

He says investigations carried out by Togolese police indicate that the brain behind the group of robbers is Ntanga Clement Didier Mogo, known as Tony, a member of the Cameroon military. He says Tony convinced his colleague, Oumarou Abo Fadil, who was in charge of weapons at Cameroon's defense headquarters in Yaoundé, to steal automatic pistols and go with him to Togo, where they could make a better living stealing and selling vehicles.

Mogo, speaking on the state broadcaster Television Togolese said he and his group traveled to Lomé to buy cars for a senior military official he refused to name, but that they were tempted to steal when their stay was extended by COVID-19 travel restrictions.

He says that he did not plan to steal when he left Yaoundé for Lomé but that he asked his colleagues who control weapons at the defense headquarters to accompany him with pistols for security against possible attacks by highway robbers. He says after they got to Lomé, both Cameroon and Togo sealed their borders and they could not return.

Mogo acknowledged that Togolese police arrested them after they stole money and a car from a rich Togolese businessman and were trying to escape. He said it was the only act of robbery they committed.

Cameroon's military says whenever they return after facing justice in Togo, they will answer charges for the crimes committed in Cameroon and for damaging Cameroon's image in a foreign country and that for now, they are no longer members of the Cameroonian military.

Two offshore workers deaths revealed in Congo-Brazzaville

Both men had been working on Eni's Awa platform when they succumbed to illness

Two Congolese oil workers died last month after being evacuated from one of Eni's platforms off Congo-Brazzaville, although it is unclear if their deaths were as a result of the Covid-19 virus.

According to a letter sent by Eni Congo's director general Marco Rotindi to Teresa Goma, head of the government's Hydrocarbons Directorate, the Eni employee who died on 22 April was Yaba Gouassi, a health, safety and environment superintendent.

The letter said Gouassi had his annual medical check-up six months ago and was declared fit for work, but at another check-up in the week prior to his death, was found to have a cold, which improved after treatment.

However, in the week of his death, Stanislas reported feeling poorly, had lost his appetite and, after a further check-up on 22 April, was evacuated from the platform by boat.

However, an hour into the voyage to Pointe Noire, Gouassi died, despite attempts to resuscitate him using a defibrillator.

The same Eni letter reported the death of a maintenance technician — Moussanda Bouka — employed by a sub-contractor to Saipem, and who was also working on the Awa platform.

According to the letter, Bouka also had symptoms of fatigue and loss of appetite, and on arriving ashore was put in the care of his company, but subsequently died. ETC.

(Agence Ecofin) - Dans une déclaration publique faite par le président de sa Commission, Moussa Faki Mahamat (photo) l'Union africaine (UA) s'est insurgée cette semaine contre les conditions de décès de George Floyd, un Américain de race noire tué au cours d'une banale arrestation policière. Ce vendredi 29 mai, l'institution a qualifié de « meurtre » la mort de l'homme de 46 ans qui était simplement soupçonné d'avoir tenté d'utiliser un faux billet de 20 \$ pour effectuer un achat.

« Le président de la Commission de l'Union africaine, Moussa Faki Mahamat, condamne fermement le meurtre de George Floyd qui s'est produit aux Etats-Unis d'Amérique aux mains des forces de l'ordre, et souhaite présenter ses plus sincères condoléances à sa famille et à ses proches », peut-on lire dans un communiqué publié ce 29 mai sur le site de l'Union africaine. « Il exhorte en outre les autorités des Etats-Unis à intensifier leurs efforts pour garantir l'élimination totale de toutes les formes de discrimination fondées sur la race ou l'origine ethnique », ajoute le document.

La déclaration intervient alors que cet énième décès d'un Noir américain suite à des violences policières, déclenche depuis plusieurs jours des émeutes aux Etats-Unis. La vidéo de George Floyd, non armé, menotté et plaqué au sol a suscité une vive émotion sur la toile. On peut y voir un policier blanc agenouillé sur le cou de la victime pendant plusieurs minutes, alors que celle-ci agonisant ne cessait de se plaindre de ne pas pouvoir respirer.

Ni les passants qui filmaient la scène en s'insurgeant contre le drame en cours, ni les plaintes de la victime n'ont ébranlé les forces de l'ordre impassibles même après que George Floyd a subitement cessé de gémir, inanimé. D'autres vidéos suggèrent la présence de trois autres policiers, immobilisant complètement la victime.

Des violences policières répétitives

La phrase « I can't breathe » (je ne peux pas respirer), prononcée par George Floyd et rappelant le meurtre en 2014 d'Eric Garner, (un autre Noir américain tué dans des conditions similaires par des policiers blancs), est devenue le slogan de la contestation contre le racisme aux USA. Jeudi soir, des manifestants ont incendié un commissariat de Minneapolis dans le nord du pays, lors d'une troisième nuit consécutive d'émeutes populaires.

Malgré la fin théorique des discriminations aux Etats-Unis selon la loi, le pays reste profondément marqué par le racisme contre la population noire. Ces dernières années, les cas de personnes noires tuées lors de violences policières n'ont cessé de se répéter. Selon une étude publiée en 2019, les Noirs ont 2,5 fois plus de chance que les Blancs d'être tués par la police au pays de l'Oncle Sam.

Huawei set-up to let Angolan students attend classes online

Huawei Technologies Co. Ltd of China has come up with a way to teach Angolan students online while the Covid-19 pandemic confines them to their homes, Angop reports.

The Angolan state-run news agency says Huawei has begun testing the set-up last month.

The report says the arrangement will let students at seven Angolan institutions of higher education attend classes virtually for six months.

Angop quotes Ermelinda Cândido, head of Cinfotec, one of the institutions, as praising Huawei's initiative.

It quotes a representative of Huawei in Angola, Luís Gonçalves, as saying the arrangement may be extended this year to serve seven other institutions, with the certification process ongoing for several of them.

One of the purposes of the set-up is to keep up "TIC Talent," the Huawei programme of training people in information communication technology so they can obtain internationally recognised qualifications, which about 70 Angolan students have availed of since 2015, Angop says.

Protests, anger over police killings sparked by George Floyd's death sweep U.S.

Americans began cleaning up charred and glass-strewn streets Sunday after another night of unrest fuelled by rage over police mistreatment of black Americans destroyed businesses, damaged landmarks and raised tensions across a divided nation to the boiling point.

The chaos reached into every corner of the country, and the scars extended even to buildings near the White House. Some elected officials prepared to deploy additional National Guard troops in anticipation of more turmoil.

Tens of thousands of people marched peacefully to protest the death of George Floyd, a black man who died Monday after a white Minneapolis police officer pressed his knee on his neck until he stopped breathing. But many demonstrations sank into violence as night fell: Cars and stores were torched. The words "I can't breathe" were spray-painted all over buildings. Police responded with tear gas and rubber bullets.

The scale of the protests, sweeping from coast to coast and unfolding on a single night, rivaled the historic demonstrations of the civil rights and Vietnam eras. And by Sunday morning, the fury had spread to Europe, where thousands gathered in London's Trafalgar Square, clapping and waving placards despite government rules barring crowds because of the COVID-19 pandemic.

"We're sick of it. The cops are out of control," protester Olga Hall said in Washington, D.C. "They're wild. There's just been too many dead boys."

Tens of millions of people in Africa could become destitute as a result of COVID-19 and its catastrophic impact on fragile economies and health systems across the continent, human rights chiefs from the United Nations and the African Commission warned on Wednesday.

UN High Commissioner for Human Rights Michelle Bachelet, and Chairperson of the African Commission on Human and Peoples' Rights, Solomon Dersso, issued a joint call for urgent measures to mitigate the ripple effects of COVID-19 on the most vulnerable.

"We cannot afford to stand idly by and hope this most viral and deadly of diseases bypasses Africa, which is home to many of the world's poorest countries who are simply not in position to handle such a pandemic", Bachelet and Dersso said.

Cases in every country

As of 19 May, COVID-19 had reached all 54 African States, infecting 88,172 people – 16,433 of them in South Africa, which recorded the highest number of cases. The continent had lost a total 2,834 people to the virus.

Poverty, lack of social protection, limited access to water, poor sanitation infrastructure, pre-existing disease burden, conflict and overstretched health systems, have created heightened risk for spreading the disease.

Ms. Bachelet and Mr. Dersso called for equitable access to COVID-19 diagnostics, therapeutics and vaccines, urging creditors of African countries to freeze, restructure or relieve debt.

"This health crisis - along with the debt burden of the continent and its already fragile economies - threaten to further drain reserves, cripple nascent job creation schemes and annihilate gains made in social development," they said.

Potential poverty explosion

Such losses could "throw millions more people into want and poverty," they said, pointing out that the costs of water and basic commodities have already spiked in many countries. People are facing hunger due to disrupted access to food and cooking fuel. Recession in the region now looms large for the first time in more than 25 years.

"It is a matter of human rights necessity that there must be international solidarity with the people of Africa and African Governments," they said. Priority investments are needed in health, water and sanitation, social protection, employment and sustainable infrastructure.

Acknowledging the economic pain

The pair said that while measures to restrict movement and increase physical distancing were essential in the fight against the virus, they are now having a dramatic impact, in particular, on those who rely on informal daily work for their survival.

In addition, the human rights experts underlined the importance of preserving freedom of association, opinion and expression, as well as access to information during this critical time. They called on Governments and businesses operating in Africa to consider making Internet tariffs more affordable so that information can reach broader audiences.

Learning from Ebola, malaria

More broadly, the rights chiefs said Africa has learned from its experiences with Ebola and malaria about the need to take swift action in countering disease spread. They reminded African Governments that it is a legal imperative - and a pre-requisite for success – that they protect the most vulnerable and stamp out any violations that emerge during the pandemic, including

discrimination in all its forms, violence against women, food insecurity, excessive use of force and extrajudicial killings.

UN chief António Guterres is encouraging Egypt, Ethiopia and Sudan to persevere with efforts to overcome their differences and reach agreement on the Grand Ethiopian Renaissance Dam.

Through his spokesperson, the Secretary-General noted on Tuesday that "good progress" is being made in negotiations between the three countries in hopes of achieving a mutually beneficial agreement.

Going up along the Blue Nile near the border with Sudan, and under construction since 2011, the \$4.5 billion dam – also known by its acronym GERD - will be Africa's biggest hydroelectric power plant once completed.

Negotiations centre on the pace at which Ethiopia fills the 74 billion cubic metre reservoir behind the dam and the impact that could have on water supplies downstream in Sudan and Egypt.

Ethiopia is keen to start filling the reservoir in July.

"The Secretary-General underscores the importance of the 2015 Declaration of Principles on the GERD, which emphasizes cooperation based on common understanding, mutual benefit, good faith, win-win, and the principles of international law," the spokesman said.

"The Secretary-General encourages progress towards an amicable agreement in accordance with the spirit of these Principles," he added.

Resolving differences

Cairo, Addis Ababa and Khartoum have all indicated their willingness to resume discussions, but differences linger over the appropriate mechanism for such talks.

UN experts say that Egypt wants to put international pressure on Ethiopia to agree to a proposal - put forward by the United States and World Bank - on the dam's first filling and annual operation.

But Ethiopia is rejecting that idea as severely limiting the dam's capacity to generate electricity and curtailing rights to future upstream development, among other reasons.

Egypt also insists that Ethiopia must not start filling the reservoir until an agreement is reached, in line with its interpretation of the Declaration that Ethiopia is contesting.

The Secretary-General encourages progress towards an amicable agreement -- UN Spokesperson The Declaration, signed in March 2015, outlines the parties' commitment to cooperation and to resolve differences through negotiations. It also states that if a dispute cannot be resolved, the matter can be referred to the heads of State and Government with an option for a joint request for mediation.

Ethiopia favours resolving the dispute at the trilateral level and has historically been against internationalizing the issue, seeing no mediation role for the United Nations.

On 13 May, Sudan's Ministry of Irrigation said that the country could not agree to an Ethiopian proposal on the initial filling as it failed to address longer-term technical, legal and environmental issues.

According to news reports, Egypt also dismissed the Ethiopian proposal on the initial filling, writing a letter to the Security Council on 1 May calling on Ethiopia to respect its obligations and resume talks.

Ahead of presidential and local elections in Burundi on Wednesday, the African Union (AU) Commission and the United Nations (UN) urged the authorities to provide a safe and secure environment for citizens to cast their votes.

In a joint statement issued on Sunday, the partners said they have been following the electoral campaign and remain concerned about reports of intimidation and violent clashes between supporters of opposing sides.

"The two Organizations encourage all entities involved in organizing the 20 May 2020 elections, the defense and security forces and state-owned media to fully contribute to preserving a stable and peaceful environment, pre-requisite for free, inclusive, fair, transparent and credible elections in Burundi," the statement said.

"They urge all political actors to refrain from all acts of violence and hate speech, and resort to dialogue, to enable the holding of consensual and peaceful elections. They also encourage the Burundian authorities to ensure and facilitate the full participation of women during this electoral process."

The AU Commission and the UN Secretariat also called on political parties to abide by the Code of Conduct which they had signed last December.

Authorities in the East African country were also urged to implement preventive measures to protect citizens from the COVID-19 pandemic.

Last week, a UN Commission of Inquiry also expressed alarm over violence and human rights abuses in the run-up to the vote.

Members also deeply regretted the government's decision to expel four staff members of the World Health Organization (WHO) from the country.
